

CTC / BIGPEAKS DEVON DIRT: Terms and Conditions

This event is run under CTC rules

The Devon Dirt is NOT a race or trial of speed, but can be challenging and hilly. You are expected to follow the rules of the road and show consideration to other road users. The route is on open public roads, bridleways and tracks. . You should prepare by studying the route.

The route will be marked by fairly small arrows – but we cannot guarantee the security of the placement of these signs. There are no marshals except at checkpoints.

You're solely responsible for your safety/conduct. A rescue service is not guaranteed but we will endeavour to help if you have a major mechanical breakdown.

The CTC provides these routes on a voluntary basis. The provision of the routes does not imply a guarantee of safety and the riders must consider themselves on a private excursion and ensure that their cycles are in roadworthy condition and that they have the experience and level of fitness to complete the ride.

Tri-bars are not permitted. Mountain Bikes (hard-tail / full suss /29er) are suitable as are CX or sturdy touring bikes although they may not cope so well on technical sections.

Parental Consent for CTC cycling activities

All participants under 18 years must be entered by their parent/guardian and be accompanied by a responsible adult cycling with them in loco parentis.

The Devon Dirt does not accept entries from unaccompanied cyclists under 18 years old. There is no lower limit if accompanied by a responsible adult acting in loco parentis. Children are welcome but parents/guardians must understand while the CTC extends a welcome to cyclists of all ages and abilities there is no special provision made for children on this activity.

Parents/Guardians must be aware of the demands of any activity, and that they alone make the decision about the ability of the child to complete the activity. Arrangements to get to and from the ride are wholly their responsibility.

CTC, its members, agents and other participants may take photographs during the course of this event, mostly for private use, but some may be used for local or national publicity purposes, or appear on our websites. You must therefore accept that photographs, in which your child appears, could be used for any of these purposes.
